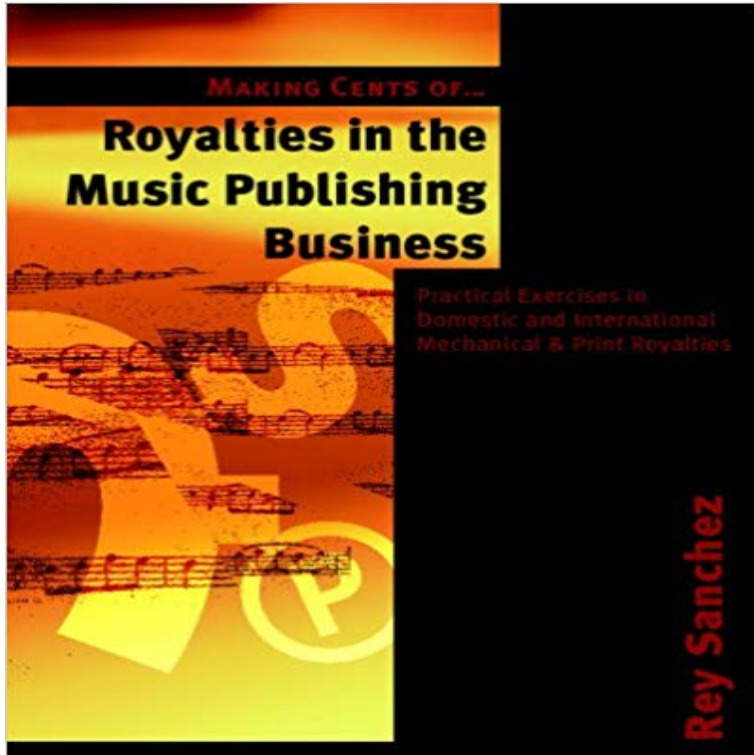


# Royalties In The Music Publishing Business: Practicle Exercises In Domestic And International Mechanical & Print Royalties
