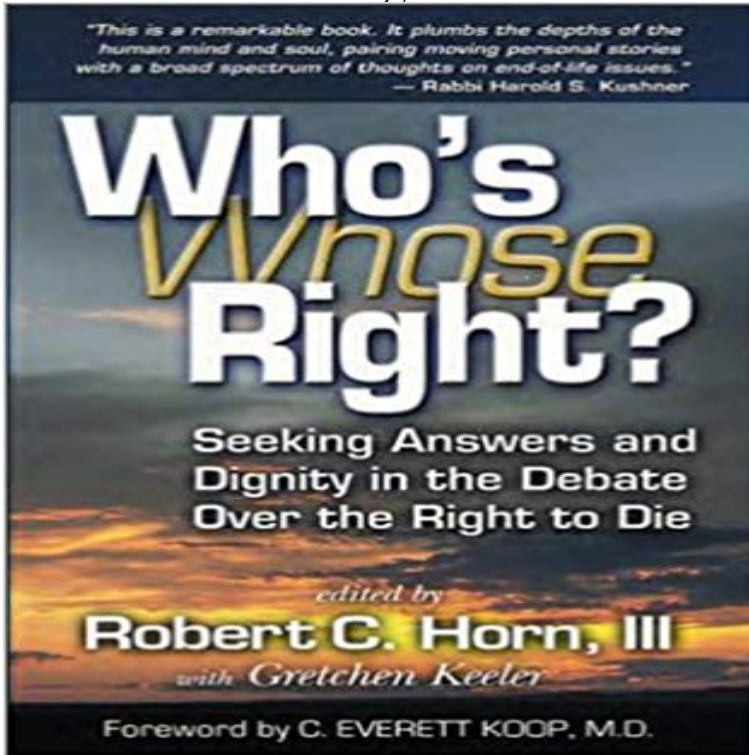


Whos Right? (Whose Right?): Seeking Answers and Dignity in the Debate Over the Right to Die



Truly the first book of its kind to take a completely objective look at the issues that surround one's right to make a choice in end-of-life decisions. Edited by 13-year ALS survivor, Robert Horn, the book offers intimate interviews with 11 individuals who have faced terminal situations and have made specific decisions on how they are facing the end of their lives. In and around each interview are commentaries by 31 experts from various fields (law, medicine, psychology, nursing, hospice, religion) who provide opinions on both sides of the issues. Among the experts appearing in the book are: Derek Humphry (best selling author of Final Exit), C. Everett Koop, M.D. (former US Surgeon General), Edward Rivet (Right to Life of Michigan), Elaine Buzzinotti, RN, JD, Faye Girsh (Hemlock Society), Rita Marker (International Anti-Euthanasia Task Force) and Dr. Bill Bright (Campus Crusade for Christ).
