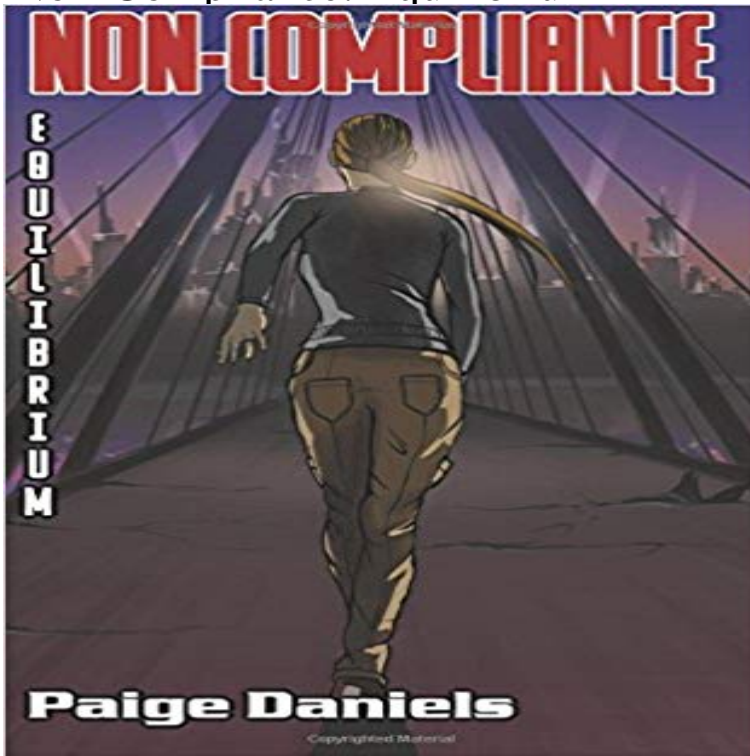


Non-Compliance: Equilibrium
