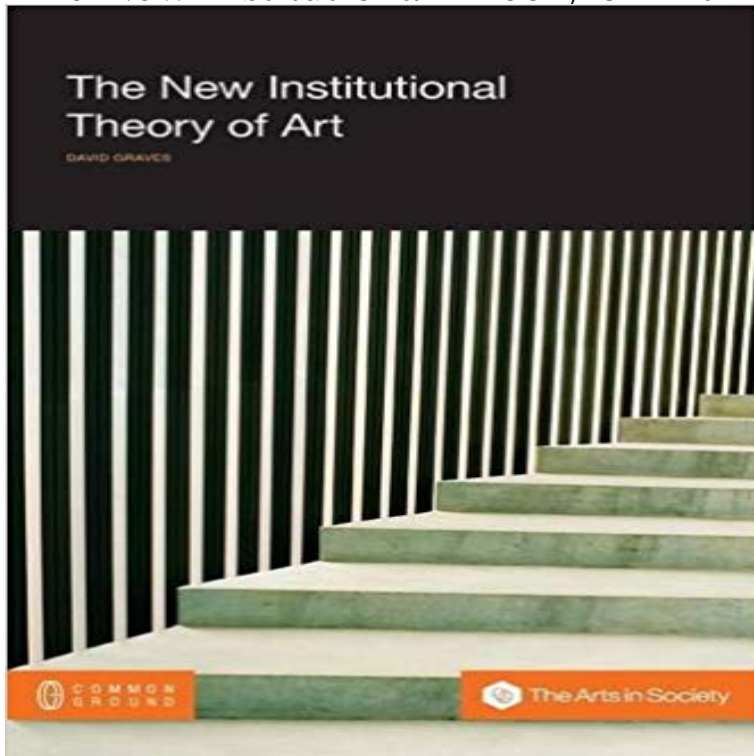


The New Institutional Theory of Art

Together with this, the theory can also explain why it is that Michelangelos work is magnificent, whereas Duchamps is interesting, at best. By focusing not on the works of art themselves, but rather upon the complex social-cultural context of their creation and presentation, the New Institutional Theory provides fresh, clear and powerful explanations of the very inner workings of Art, writ large. The artists, the public, the issues, the techniques, the bothers and the worries are all illuminated for the reader to gain true insight into the actual logic of Art.
