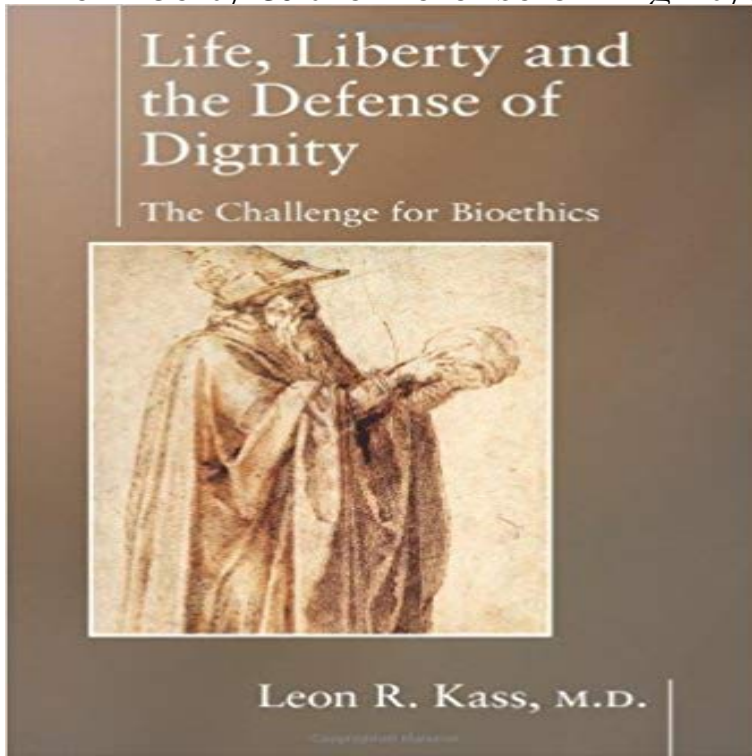


## Life Liberty & the Defense of Dignity: The Challenge for Bioethics
