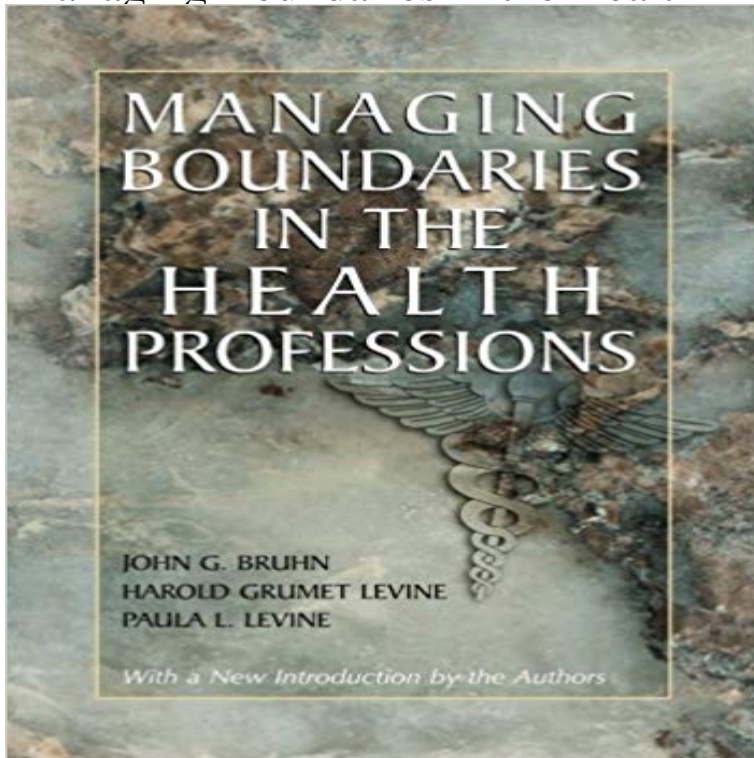


# Managing Boundaries in the Health Professions
