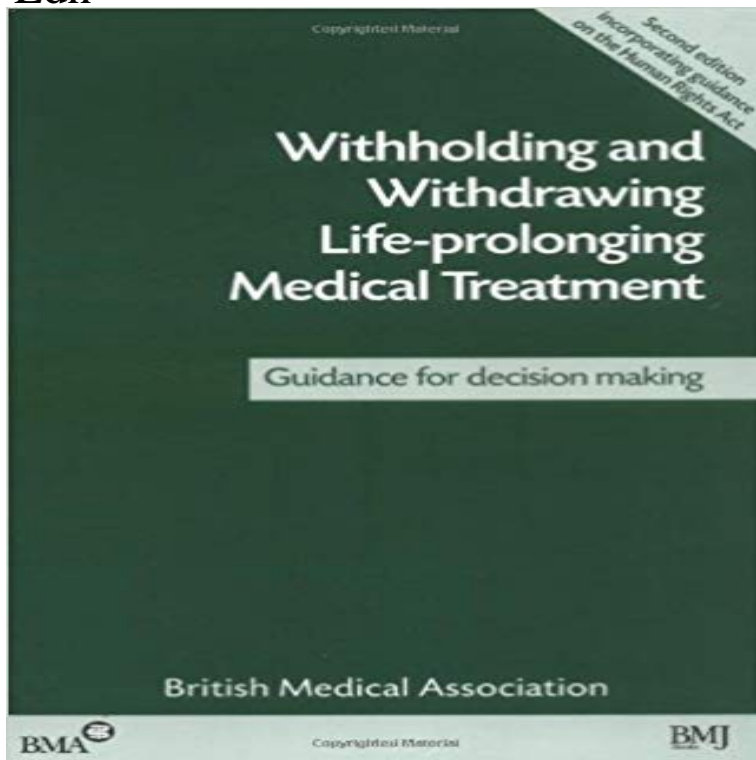


# Withholding & Withdrawing Life Prolonging Medical Treatment 2nd Edn
