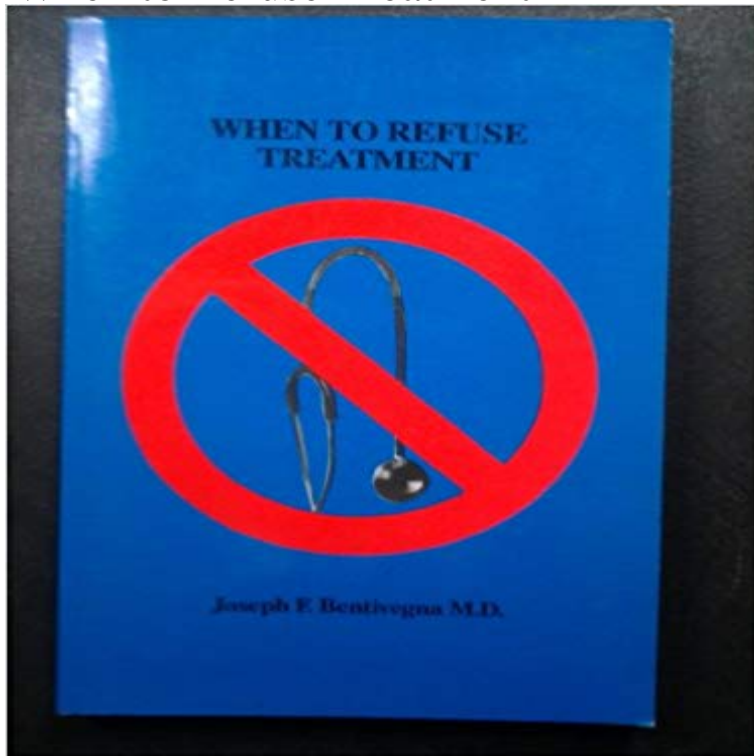


When to Refuse Treatment
