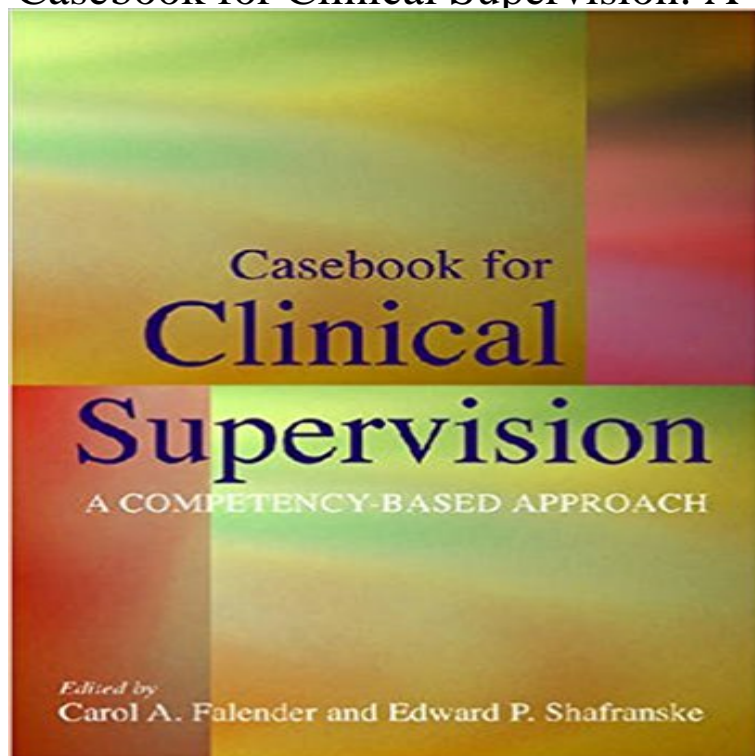


## Casebook for Clinical Supervision: A Competency-Based Approach
