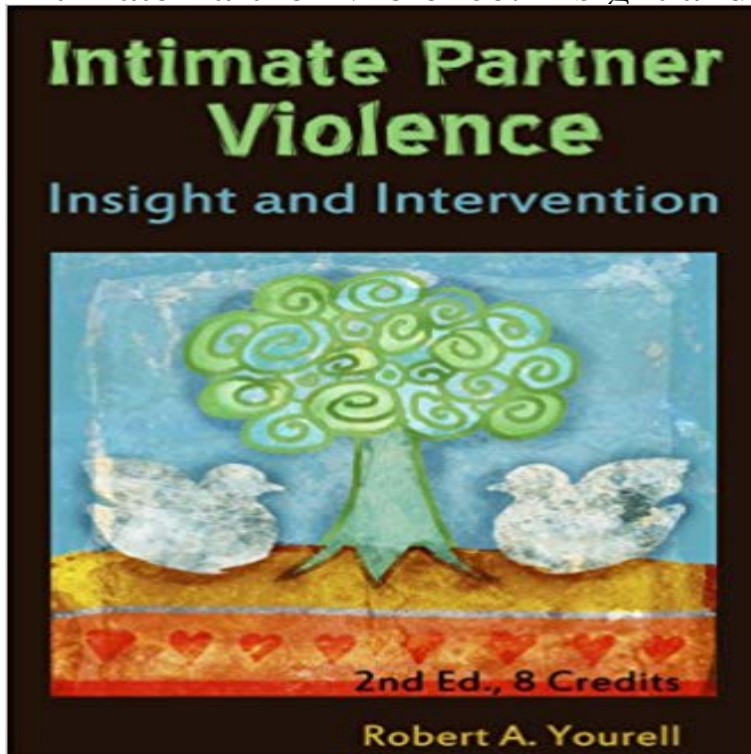


Intimate Partner Violence: Insight and Intervention, 8 Units



This course provides an up to date and detailed overview of intimate partner violence (IPV), also referred to as domestic violence (DV). It is designed for practicing psychotherapists and is useful for other mental health professionals as well. It includes a clear description of the state of research support for current trends in batterer and victim treatment. It draws treatment and program recommendations and prevalence rates from the strongest sources, including a very large, recent metastudy involving 20 universities and research institutions known as The Partner Abuse State of Knowledge Project (PASK). The course reflects current understandings of IPV that include the mental health and treatment needs in victims, perpetrators, and those in mutual violence. It includes knowledge pertaining to diverse groups such as LGBT populations. It provides a review of historical developments and their current trends in shaping professional perspectives and programs. As a result of taking this course, the participant will be able to: Define IPV. Recognize psychological abuse in IPV. Know the factors that contribute to IPV. Describe two primary types of excessive control in relationships. Recognize the tactics of control used by antisocial abusers. Understand IPV scope, demographics, and incidence rates. Know the history of IPV from the shelter movement and related activism up to current events and laws affecting clinical thought and service delivery. Understand typical mental health needs in IPV cases. Recognize common profiles of batterers and victims. Understand how attachment disorders and poor affect regulation are factors in IPV. Identify the treatment trends that are benefiting batterers and victims. Recognize diversity issues in IPV, including those of the LGBT community. Recognize controversies in

IPV, and the current limits of research into IPV. Learn how the stereotype of the psychopathic male batterer came to represent all batterers. Learn the nature and limitations of the cycle of violence concept. Discover the numerous reasons why people remain in or return to abusive relationships, including positive, rational reasons, dysfunctional reasons, and reasons stemming from control tactics by abusers. Know the effects of IPV on victims and children. Understand separation violence. Deal effectively with legal and ethical issues related to IPV. Robert A.
