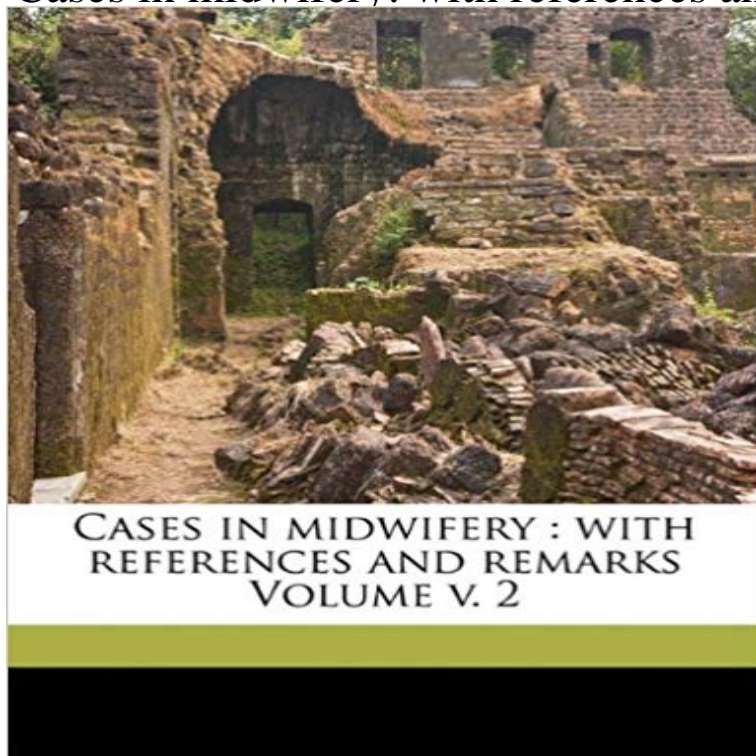


## Cases in midwifery: with references and remarks Volume v. 2
