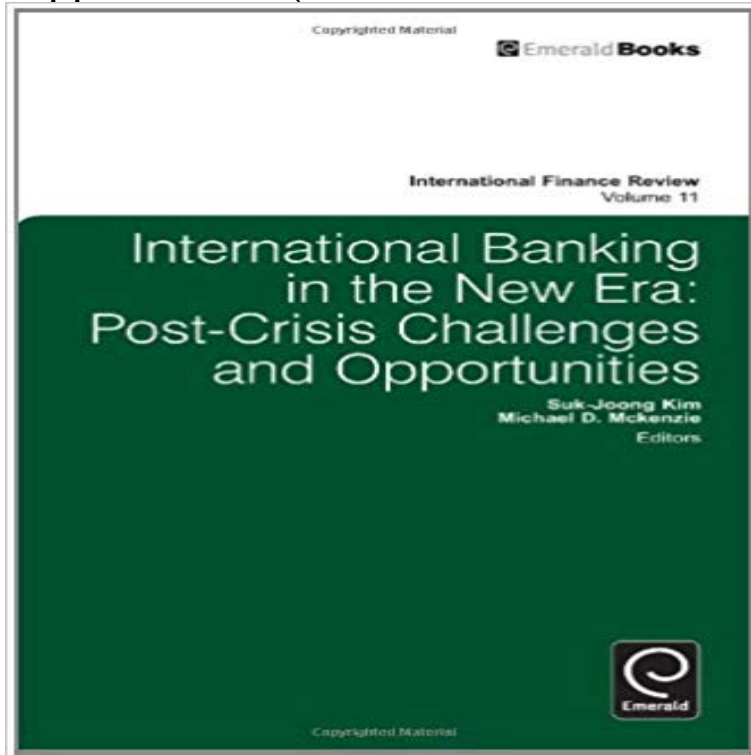


# International Banking in the New Era: Post-Crisis Challenges and Opportunities (International Finance Review)
