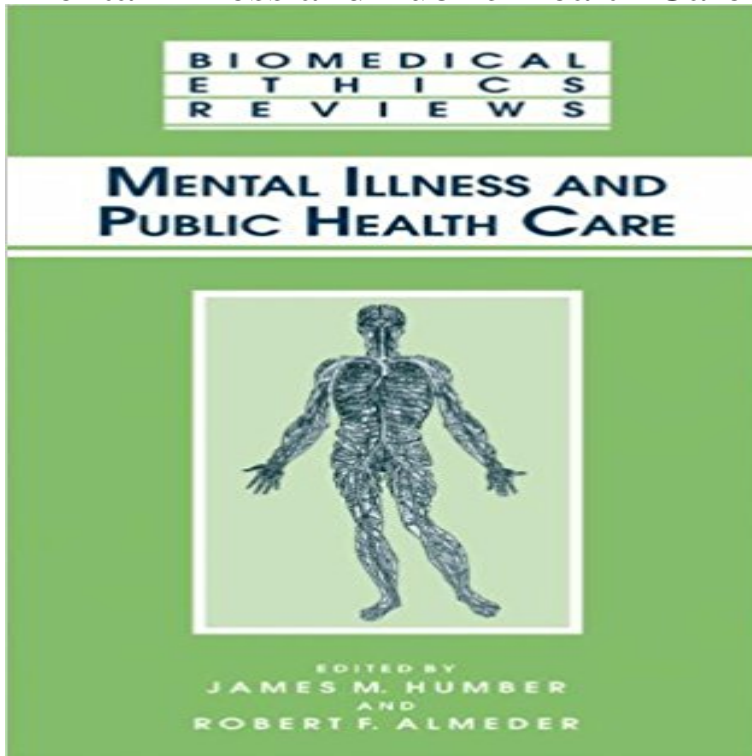


## Mental Illness and Public Health Care (Biomedical Ethics Reviews)
